



RONILAČKA MREŽA j.d.o.o. – DIVING NETWORK s.l.l.c. Program – ISTR DIVING NETWORK

1. REGULATIONS

- 1.1. Diving Network (**DN**) is the organizer and mediator between the seller and service provider
- 1.2. Service Provider (**SP**) is every diving center – contractual member of **DN**
- 1.3. Service Seller (**SS**) is every legal subject (*Tourist agency, Tour operator, Company, Association, Agent...etc.*) – contractual member of **DN**
- 1.4. Full day excursion are organized as two dives without returning to diving center or with returning to diving center between two dives, depending on the organization of the diving center
- 1.5. All dives are organized with duration of maximum 60 minutes and maximum 39 meters of depth, without deco stops and with obligatory safety stop on 3-5 meters/3-5 minutes
- 1.6. Necessary diving certificates:
 - 1.6.1. dives till 18 meters – minimal category Open Water Diver or equivalent (*OWD*)
 - 1.6.2. dives till 30 meters – minimal category Advance Open Water Diver or equivalent (*AOWD*)
 - 1.6.3. dives on wrecks – minimal category Deep Diver or equivalent, or AOWD or equivalent with proof of minimal 40 dives (*Log Book*) with obligatory use of dive computer (*own or rental*)
 - 1.6.4. night dives – minimal category Night diver or AOWD or equivalent
- 1.7. All dives are organized with boat/rubber boat except in the case of unsafe or bad weather or night dive (*organization of the night diving depending on the organization of the diving center*)
- 1.8. **SP** keep the rights of changing the dive position or canceling the dive in the case of unsafe or bad weather with prior notice to the administration of **DN**
- 1.9. In the case of unsafe or bad weather, **DN** will offer alternative dive destination (*transfer +1 dive*)
- 1.10. Organized dives include infrastructure of diving center, boat/rubber boat, kit with oxygen, tank filling with air and dive guide
- 1.11. Infrastructure of diving center consists of a space for washing diving equipment, space for storage and drying diving equipment, space for filling scuba tanks and sanitary block
- 1.12. Boat/rubber boat is registered for 12 persons
- 1.13. Dive guide, by the regulations of Croatian government, is not obliged (*except on locations under government protection*) to dive with the group, but is obliged to dive in all contract packages of **DN** as a guide without responsibility for individual acts of divers in the group and has the right to assess the cancellation of diving for each individual inside the group on the basis of his current psychosomatic status with prior notice to the administration of **DN**
- 1.14. Organized dives are valid only for groups of **8 – 11** divers in a package of minimum 2 (*two*) dives
- 1.15. Is obliged to pay 30% of the agreed package on the day of booking (*min. 30 days before agreed package*)
- 1.16. Payment of 30% of the agreed package is non-refundable
- 1.17. Reservation is confirmed on the day of 100% payment of the agreed package (*min. 15 days before the agreed package*)
- 1.18. Possibility of booking within 30 days prior to the term can be agreed with **SS**
- 1.19. If the group has less than 8 divers, the group will be canceled unless different agreement with **SS**
- 1.20. **Client** agree to deliver to **SS** latest till the day of agreed package, copy of following documents:
 - 1.20.1. last registered dive (*last dive needs to be inside 12 months*)
 - 1.20.2. approval of acceptance of responsibility
 - 1.20.3. diving certificate (*brevet*)
 - 1.20.4. proof of minimum 40 dives for dives on wrecks with AOWD or equivalent category
- 1.21. **SP** provides insurance in case of diving accident to all divers inside agreed packages of **DN**
- 1.22. **DN** keeps all rights to change diving program
